Race Director Incident Determinations

There were no determinations.

Stewards' Decisions – Penalties imposed

The Stewards imposed a 3 Grid Positions on Car 38, Cameron Crick for impeding Car 30 Aaron Seton on a Qualifying Lap for Race 2

After receiving a Technical Report on Car 3 following the Session, and an admission to the Technical Breach, Rule G1.2.1 by MW Motorsport, the Stewards Disqualified Car 3, from the Session.

STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Update 2: issued Saturday 30th April 2022 at 2000hrs.

Matters from Race 1:

Race Director Incident Determinations

During the Race the DRD, in consultation with the DSA, conducted investigations into the following Incidents:

- An Incident involving contact between Car 78, Zakkary Best, and Car 2, Steven Page at Turn 3 as a result of which Car 78 sustained damage. A review of broadcast footage revealed that no Driver was wholly or predominantly to blame for the Incident;
- An Incident involving contact between Car 49, Jay Hanson, and Car 18, Matt Chadha, at Turn 6 as a result of which Car 49 sustained damage. A review of broadcast footage revealed that no Driver was wholly or predominantly to blame for the Incident;

Stewards' Decisions – Penalties imposed

During the Race the Stewards imposed the following Penalties:

- A 15 Second Time Penalty on Car 999, Jaylyn Robotham, for Careless Driving at Turn 7 on Lap 2 causing contact with Car 30, Aaron Seton, as a result of which Car 30 lost positions.
- A 15 Second Time Penalty on Car 5 Brad Vaughan for Careless Driving on Lap 23 causing contact with Car 67, Nash Morris, as a result of which Car 67 lost positions.

Matters from Qualifying Race 1:

Stewards' Decisions – Penalties imposed

For causing the Red Flag in Qualifying (and in accordance with Rule D6.1.12), Car 8, Elly Morrow, had its fastest time (56:938) set at 14:21:03hrs deleted.

Matters from Competitors Authorised Representatives and Drivers Briefing:

The Authorised Representative for Car 5 Michael Anderson received a Fine of \$500 for failing to attend the Briefing

Matters from Practice 2:

Race Director Incident Determinations

There were no determinations.

Stewards' Decisions – Penalties imposed

The Stewards imposed a \$250 fine on Car 2, Steven Page, for failing to use the "Link Road" following the session (in contravention of Point 7 of the Competitor and Driver Briefing Instructions)

The Stewards imposed a \$250 fine on Car 96, Gary Collins, for failing to use the "Link Road" following the session (in contravention of Point 7 of the Competitor and Driver Briefing Instructions)

The Stewards imposed a \$1,000 fine on Car 2, Steven Page, for leaving Pit Lane whilst the Red Light was illuminated and Red Flags displayed (in contravention of Schedule B2 D6.3.1)

The Stewards imposed the penalty on Car 5 is relegated to start Race 1 at this Event from Pit Lane and a Fine in the sum of \$10,000 is imposed on the Competitor, Michael Anderson, of which \$5,000 is suspended until 31 December 2022, providing the Competitor commits no further breach of Rule D1.3.4 prior to that date. Race Director Incident Determinations

There were no determinations.

Stewards' Decisions – Penalties imposed

The Stewards imposed a \$1,000 fine on Car 78, Zakkary Best, for failing to use the correct "Pit Entry Road" (in contravention of the Competitor and Driver Briefing Instructions – Pit Entry). The driver had previously been warned earlier in the session for the same action.
