### STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Final: issued Sunday 10 July 2022 at 1700hrs.

#### **Matters from Race 2:**

##### Race Director Incident Determinations

During the Race the Deputy Race Director in consultation with the Driving Standards Advisor investigated contact between Car 27 Tyler Everingham, Car 78 Zak Best and Car 10 Matthew Payne following the race start and determined no one driver was wholly or predominantly to blame.

During the Race the Deputy Race Director in consultation with the Driving Standards Advisor investigated contact between Car 78 Zak Best and Car 999 Jaylyn Robotham in the vicinity of Turn 4 on Lap 1 and found no breach of Rules.

The Deputy Race Director in consultation with the Driving Standards Advisor conducted a post-race investigation into contact between Car 38 Cameron Crick and Car 67 Nash Morris at Turn 5 on Lap 6 and determined no one driver was wholly or predominantly to blame.

##### Stewards' Decisions – Penalties imposed

The Stewards imposed the following penalties:

- Pit Lane Penalty on Car 7 Jim Pollicina for passing Car 8 on Lap 1 under yellow flag conditions.
- Pit Lane Penalty on Car 76 Garry Hills for passing Cars 46 and 2 on Lap 1 under yellow flag conditions.

#### **Matters from Qualifying for Race 2:**

##### Race Director Incident Determinations

There were no determinations.

##### Stewards' Decisions – Penalties imposed

Following an admission to a breach by the Competitor, Brad Jones Racing, the Stewards imposed a \$500 fine for Car 8 Elly Morrow entering the Pit Lane after the chequered flag was displayed.

#### **Matters from Race 1:**

##### Race Director Incident Determinations

Having received a request for investigation from the Authorised Representative for Car 77 alleging Car 5 passed Car 77 at Turn 11 on Lap 1 under yellow flag conditions, the Deputy Race Director in consultation with the Driving Standards Advisor investigated the matter and found no breach of Rules.

##### Stewards' Decisions – Penalties imposed

The Stewards imposed the following penalties:

- Pit Lane Penalty on Car 4 Tony Auddino for passing Car 23 at Turn 11/12 on Lap 1 under yellow flag conditions.
- Post-race Pit Lane Penalty (equivalent to 25 seconds at this Track) on Car 219 James Masterton for passing Car 23 at Turn 11/12 on Lap 1 under yellow flag conditions.

- Time penalty of 15 seconds on Car 58 Ryal Harris for careless driving (contact on Car 67 Nash Morris at Turn 2 on Lap 11 causing Car 67 to lose multiple positions).

Following an admission to a breach by Image Racing, the Stewards imposed a time penalty of 15 seconds to be added to the race time of Car 999, Jaylyn Robotham, for careless driving (contact on Car 35 Jason Gomersall at Turn 13 on Lap 11 causing Car 35 to lose multiple positions).

### ***Matters from Qualifying for Race 1:***

#### **Race Director Incident Determinations**

There were no determinations.

#### **Stewards' Decisions – Penalties imposed**

For causing a red flag, the fastest lap time for Car 68 Shane Beikoff was deleted.

### ***Matters from Practice 2:***

#### **Race Director Incident Determinations**

There were no determinations.

#### **Stewards' Decisions – Penalties imposed**

Following an admission to a breach by MW Motorsport, the Stewards imposed a fine of \$500 for Car 3, Thomas Maxwell, exceeding the Pit Lane speed limit. The Stewards also imposed a suspended \$250 fine for a Pit Lane speed breach at Round 1 at Sydney Motorsport Park.

Following an admission to a breach by the Competitor, Jim Pollicina, the Stewards imposed a \$500 fine for Car 7 Jim Pollicina entering the Pit Lane after the chequered flag was displayed.

### ***Matters from Practice 1:***

#### **Race Director Incident Determinations**

There were no determinations.

#### **Stewards' Decisions – Penalties imposed**

Following admissions to breaches by Eggleston Motorsport and Garry Hills, the Stewards imposed the following penalties for exceeding the Pit Lane speed limit:

- Car 2, Steven Page - \$350 fine
- Car 76, Garry Hills - \$350 fine.

### ***Matters from Competitors Authorised Representatives & Drivers Briefing:***

#### **Stewards' Decisions – Penalties imposed**

A fine of \$500, with \$250 suspended until 31 December 2022, was given to James Masterton for late arrival at the Competitors Authorised Representatives & Drivers Briefing.
