STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Update (Final) issued Saturday 8th October 2022 at 1800hrs.

Matters from Race 2:

Race 2 cancelled due to extreme weather and unsafe track conditions due to running and pooling water

Matters from Qualifying Race 2:

Race Director Incident Determinations

There were no determinations.

Stewards' Decisions – Penalties imposed

Following an investigation by the DRD and admission to a breach of B6.5.6 (in that the team failed to remove an external jump battery pack before releasing the car onto the Circuit) by the Team, Car 23 Ray Hislop, the Stewards imposed a fine of \$5,000 with \$2,500 suspended until 31/12/2022. The external jump battery came loose and dislodged itself between Turns 13 and 14 onto the track, which was an avoidable event which in all circumstances could have reasonably led to personal injury and or damage.

Stewards' Decisions – Penalties imposed

Following an admission by the Team, Eggleston Motorsport Australia Pty Ltd, for failing to fully secure the front right wheel of Car 26 before releasing the car to the circuit, the Stewards imposed a fine of \$3000 of which \$1500 is suspended until 31/12/2022 on condition that the team commits no further breach of Rule B6.5.6.1 (a) prior to this date.

Following an admission to the breach by the Driver, Gary Collins Car 96, the Stewards imposed a fine of \$500 on Gary Collins, for failing to proceed immediately back to his Pit Bay when the Red Flag was displayed, Schedule B3 Rule 3.2.1.1
